Sir/Madam,

This is to inform you that, the Academic Council of this University, vide its Resolution No. 21 dated June 28, 2010 has granted the continuation of affiliation to teach the following subjects as enlisted against the concerned Faculty, for the academic year 2010-11 in accordance with the provisions of Section 86 of the Maharashtra Universities Act, 1994, subject to the condition that, the concerned Management / College gives a written undertaking to fulfill all the conditions stipulated in the reports of the concerned Local Inquiry Committee, within the prescribed time limit and that in default the continuation of affiliation so granted, be withdrawn as per the procedure laid down for the purpose.

Continuation of Affiliation for B.Sc. Interior Design Part I, II & III:

The Continuation of affiliation to teach the subjects for the academic year 2010-11, is granted on the following terms and conditions:

- 1 That the College shall meet deficits, if any, by making an outright grant to the college from its own funds.
- 2 That the College shall appoint the following staff in accordance with the qualifications and procedure, prescribed by the University / State Government/U.G.C., as the case may be.

- b. Librarian
- c. Non Teaching Staff
- d. Technical / Laboratory Staff

3. That the college shall maintain rosters for reservation of posts of teaching and non teaching staff, as per the reservation policy of the Government of Maharashtra wherever applicable and maintain service books of all employees and the provident fund registers.
4. That the college shall provide facilities for library books and journals, furniture, fixtures and fittings for class room, office, laboratories, library and staff room.
5. That the college shall constitute the Local Managing Committee / Advisory Committee, as prescribed under Section 85 of the Maharashtra Universities Act, 1994.
6. That the college shall comply with the conditions laid down by the Government with respect to admission of students belonging to SC/ST/DT-NT and OBC categories, if any.
7. That the college shall comply with the Statutes/Vice Chancellor's directives with respect to appointments of teaching and non teaching staff belonging to the SC/ST/DT-NT and OBC categories.
8. That the college shall send to the University, the progress reports from time to time towards compliance of the above conditions by the end of October and January of the following year, respectively.
9. That the College shall give an undertaking on the stamp paper worth Rs. 100/- wherein it will agree to comply with all the conditions for affiliation laid down under Section 81 of the Maharashtra Universities Act, 1994 and also agree to abide by the rules and regulations as may be framed by the University from time to time.



ORDER

In terms of Section 14 (1) of the NCTE Act, 1993 SMT. DHAIRYA PRABHA DEVI SAJATIA, WOMENS WELFARE SOCIETY 6, SNEH NAGAR, SAPNA-SONGEETA ROAD, INDORE MADHYA PRADESH had submitted an application to the Western Regional Committee of NCTE for grant of recognition for starting B.Ed. of one year from the academic session 2005-2006 with an annual intake of 100 students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- (i) The institution has acquired the land for setting up the teacher education institution.
 - (ii) The institution has constructed the building for conducting the course on the above-mentioned land.
- Or
- (iii) The institution has made arrangements for conducting the course in rented premises.
 - (iii) The institution has created an Endowment Fund of Rs. 5.00 lakhs and a Reserve Fund of Rs.3.00 lakhs.
 - (iv) The institution has initiated the process for recruitment of Principal/Head of Department and teachers for the said course.

3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to SMT. DHAIRYA PRABHA DEVI SAJATIA, WOMENS WELFARE SOCIETY 6, SNEH NAGAR, SAPNA-SONGEETA ROAD, INDORE, MADHYA PRADESH for B.Ed. of one year from the academic session 2005-2006 with an annual intake of 100 students subject to fulfillment of the following.

- (a) The institution shall ensure that it gets duly affiliated for this course to the concerned University and all other formalities required by the University are also completed before the commencement of the course and admission of the students to the course and a report to this effect should be sent to the Committee.
- (b) That the institution will ensure that 08 (one Principal and 07 lecturers) faculty members are in position for an intake of 100 students before commencement of the course and a report to this effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
- (c) The institution shall within one month of the receipt of recognition create an endowment fund account into a joint account to be operated along with an official of the Regional Committee.

- (d) The institution shall shift to its own premises within three years from the date of recognition (In case the course is started in rented premises).
- (e) The institution shall comply with the various other norms and standards as prescribed in the NCTE Regulations.
4. Recognition is subject to the condition that the affiliating University shall ensure that, among other things, an institution has appointed required number of faculty members (including Principal/Head of Department) as per the norms of the NCTE/State Government.
5. Further, the recognition is subject to the fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university/State Directorate of Education to the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.
7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
